Important Summer Student Information

- **Account credentials:** Once notified of your acceptance into summer sessions at Lehigh, you will need to create a Lehigh account login through <https://accounts.lehigh.edu/new/>. You must use the email address that was provided on your application in order to complete this process.
- **Bills/Payments:** You are responsible for all tuition and fees associated with your registration. Payment for Summer Sessions is due five days prior to the start of classes. If registration occurs after bills are issued, payment is still due prior to the start of classes (<https://financeadmin.lehigh.edu/content/payment-calendar>). Payments are made using the Bursar's Office eBill Suite. Once you have opened your Lehigh account, you may log in at go.lehigh.edu/ebill using your Lehigh credentials. If someone else is helping you with your tuition expenses, we recommend you set them up as an Authorized User (<https://financeadmin.lehigh.edu/content/paying-online>).
In order to issue a 1098-T, the Bursar's office requires a complete W9S. Please review and submit the enclosed form to the Bursar's office as instructed on the document. This information is on your acceptance letter or can be found on the [course registration menu](#). **NOTE:** If you do not attend your registered course(s) and do not contact our office to drop the course(s) prior to the course start date, you are still financially responsible for tuition.

- **ID Cards:** Summer sessions students are eligible to obtain a Lehigh ID card. ID cards allow access to many campus resources and can be used for a GoldPLUS account (see below). Visit go.lehigh.edu/id for information on obtaining an ID card.
- **GoldPLUS:** GoldPLUS works like a debit account, but it is encoded right on the Lehigh ID card. GoldPLUS is accepted at hundreds of locations on and off campus, including many eating establishments, library copiers, vending machines, the bookstore, and more.
