Please note:

- If you are a current Lehigh student, you will need to obtain your summer pin for registration from your advisor. If you are an incoming student for the upcoming Fall semester, you need to complete this application.
- This application is only for undergraduate enrollment for summer semester. <u>Graduate students</u> should contact the Dean's office in the college in which they wish to enroll for summer study.
- LVAIC students should use a cross-registration form available from their home institution's Registrar's Office.
- Students interested in a Study Abroad program should contact the <u>Study Abroad Office</u>.

Registration and Academic Services will begin processing applications in late April on a rolling basis until the start of term.

Please be advised that registration will be granted based upon seat availability in your selected courses. If a course is full, you will need to contact the Professor for an override into the course. You can use the <u>Lehigh</u> <u>Directory</u> to find contact information if needed. Overrides are not guaranteed and are issued at the department's discretion.

 Account credentials: If this is your first time taking a course through Lehigh University, you must activate your Lehigh account by visiting <u>https://accounts.lehigh.edu/new/</u> and using the email address that was provided on your application. If you've previously opened an account and no longer have your login credentials, please visit www.lehigh.edu/forgot. If you have other technical difficulties with your account, please contact the <u>LTS Help</u> <u>Desk</u> for assistance.

Once you've established your account, you'll have access to your Lehigh University email address, CourseSite (used for online components of your course), Banner (used for viewing your schedule and grades), and other University online resources by visiting <u>connect.lehigh.edu</u>. Please monitor your Lehigh email for updates on your account and billing statements.

 Bills/Payments: You are responsible for all tuition and fees associated with your registration. Payment for Summer Sessions is according the Bursar's office <u>Payment Calendar</u>. Payments are made using the <u>Bursar's</u> <u>Office eBill Suite</u>. Once you have opened your Lehigh account, you may log in at <u>go.lehigh.edu/ebill</u> using your Lehigh credentials. If someone else is helping you with your tuition expenses, we recommend you set them up as an Authorized User.

In order to issue a 1098-T, the Bursar's office requires a complete W9S. Please review and submit the enclosed form to the Bursar's office as instructed on the document. - **GoldPLUS:** GoldPLUS works like a debit account, but it is encoded right on the Lehigh ID card. GoldPLUS is accepted at hundreds of locations on and off campus, including many eating establishments, library copiers, vending machines, the bookstore, and more. Please include the CRN, subject, course number, and section. This information is on your acceptance letter or can be found on the <u>course registration</u> menu. NOTE: If you do not attend your registered course(s) and do not contact our office to drop the course(s) prior to the course start date, you are still financially responsible for tuition.
